## Plan International UK London Marathon 2019 Golden Bond Application Terms and Conditions



Important - please read these Terms and Conditions. By checking the box below you confirm you have read, understood and agreed to these:

## **General Terms:**

- Plan International UK is limited to 10 Golden Bond places (guaranteed London Marathon 2019 entry) that are subject to availability and acceptance.
- If my application is successful Plan International UK will be in touch to collect my deposit of £75.
- In order to apply for a Golden Bond place I have enclosed my application form, a signed copy of these terms and conditions.
- Should my application be successful I pledge to raise a *minimum* of £2,000 sponsorship (in addition to my deposit of £75 and exclusive of Gift Aid) through my own sponsorship generating activities and I will pay this amount to Plan International UK by cheque, credit card or via JustGiving/Virgin Money Giving *no later than 1 June 2019.*
- If I need more time to collect personal sponsorship pledged by others I will let Plan International UK know in writing, in advance of the 1 June 2019, so any necessary arrangements can be made.
- If I fail to meet my fundraising target of £2,000 Plan International UK has been asked to inform Virgin London Marathon company, who will keep your details on file. This may affect your ability to run the Virgin Money London Marathon in the future.
- Any fundraising materials that I may produce of my own accord must include the phrase "Plan International UK is a charity registered in England and Wales No 276035"
- As a Golden Bond runner I agree that any images taken of me on the day may be used by Plan International UK to promote future events.
- I am or will be at least 18 years of age on the date of the Marathon (28 April 2019).
- I acknowledge that I am taking part in this event at my own risk.

## Golden Bond withdrawal including injury:

- If I sustain a training injury I will contact Plan International UK immediately to review the situation as I realise the importance of being completely fit to participate in the Marathon.
- If I choose to withdraw from the Virgin Money London Marathon 2019 through injury or any other reason I will let Plan International UK know immediately to give the opportunity for another runner to take up the Golden Bond place.
- Following acceptance of a place. If I choose to cancel my place for any reason and no substitute runner is found for my place, by no later Thursday 24 January 2019. I will pay Plan International UK the sum of £260.00 as an administration fee for the Golden Bond place I am forfeiting.
- In the event that I need to withdraw my accepted entry, I will inform Plan International UK in writing and advise all my sponsors of my withdrawal.
- I will advise my sponsors that any sponsorship monies which have already been paid to Plan UK
  will be fully refunded by Plan International UK to them should they request it; they will need to
  contact Plan International UK to facilitate reimbursement.
- I will repay any sponsorship I have collected personally and which has not been passed to Plan International UK, to my sponsors directly within 30 days of my withdrawal.
